<u>DAMAGES OR MISSING ITEMS</u>: Stello Construction will not be held responsible for any damage to the property or items missing, switched out, lost, damaged or stolen under any circumstances including but not limited to theft, vandalism, negligence of invited or uninvited individuals, or acts of nature.

TERMINATION: Either party may terminate this Service Contract with 30 (thirty) days written notice. Upon cancellation, Stello Construction shall return all keys, codes, and openers to Client and Client shall submit all fees due and payable to Stello Construction within 10 (ten) days of receipt of termination notice.

AUTHORIZATION AND APPROVALS:

- All parties confirm the Service Contract provided by Stello Construction and the information provided by the client is understood and agreed upon.
- Inaccurate or incomplete information is the responsibility of the client and will void all responsibility of said services.
- This document confirms the approval for limited access to the client's property for the home monitoring services.
- Any emergency will be handled as detailed in this form set with charges due upon per agreed conditions.

ADDITIONAL INFORMATION
